Conservator It had recently come to the Secretary's attention that retired employe, Timothy J. Crowley had been committed to the Manteno State Hospital, and was no longer able to transact business. Mr. Crowley's family was subsequently notified that a conservator had to be appointed for him. Mr. Storm stated that the letters of conservatorship had been received and it was the Committee's decision that future retirement payments for Mr. Crowley will be made payable to his son as conservator.

Applications for Retirement

The retirement applications of Harvey M. Nissley and William Seidel. which were held over until this meeting by the Committee's order pending further substantiation of the date of birth of each of these men, were again reviewed at this meeting. The Committee decided that the application of Harvey M. Nissley be approved effective April 1, 1945, due to the fact that additional proof had been received prior to April 1st, and that the application for William Seidel be approved effective May 1. 1945, because additional proof had been received just prior to this meeting.

In addition to the above applications, the following were accepted, as per attached List No. 43:

> Five from the Transportation Department, two from the Shops & Equipment Department, three from the Track Department, and one from the Building Department. The application of Dugald Lamont from the Building Department was approved retroactively to April 1, 1945 inasmuch as the Committee felt that this employe should not be penalized when it was not his fault for late filing of application. For record purposes, Mr. Manning made a motion. seconded by Mr. Devane that all applications be accepted, to which the Committee agreed. This makes a total of 1,290. applications approved to date.
