Eleven from the Transportation Department, one from the Shops and Equipment Department and two from the Track Department. Mr. Bedore made a motion, seconded by Mr. Devane, that the 14 applications be approved. Motion passed. This makes a total of 2,240 applications approved to date.

Mr. Devane made a motion, seconded by Mr. Bedore, that the applications of Patrick C. Vaughn and George J. Mr. Devane made a motion, seconded by Mr. Bedore, that the additional five applications be approved. Both motions passed. This makes a total of 155 applications approved to date.


Returned




Mr. Forsythe stated that due to the new Pension Award by the Board of Arbitrators, he did not know if this Committee would meet again, if so, all would be notified.
