The Chairman called the meeting to order at 10:30 A.M.

On a motion by Mr. Keiser seconded by Mr. Flynn, the minutes of the 275th Meeting held on April 17, 1972 were unanimously approved.

The announcements of deaths since the last meeting were made by the Secretary as per the attached listing.

The Secretary advised that four (4) employes submitted Survivorship Options for presentation at this meeting. On a motion by Mr. Flynn seconded by Mr. Keiser the four (4) applications for Survivorship Options were unanimously approved.

The Secretary advised that thirty-three (33) applications for retirement were submitted to this office for presentation at this meeting. The Secretary presented Chicago Transit Authority bills totaling \$12,513.81 and miscellaneous bills totaling \$51,074.03 for approval. On a motion by Mr. Donnelly seconded by Mr. Flynn, the Committee unanimously approved payment of these bills.
